



## Pricing for In-Home, School-Based, and Teletherapy Services

**Thirty (30) Minute In-Home Consultation \$75:** Includes review of all documentation related to previous evaluations and current therapy services. This consultation provides an opportunity for the clinician, family, and individual to meet and discuss options for assessment and treatment. The consultative fee is applied directly to the cost of an evaluation (if an evaluation is scheduled within 3 months of the initial consultation)

**IEP meeting consultations (billed at the hourly rate of \$100):** Includes in-person presentation/discussion of the written speech/language/literacy evaluation to IEP team members and support for families seeking school system services to address their child's needs

**Travel Fee: \$50** per visit outside a 20-mile radius of 23451

## Evaluation Services

**Speech and Language Evaluation: \$300** Includes up to 2 hours of in-person test administration and parent counseling, followed by completion of a written report

**Literacy Evaluation: \$500** Includes up to 3 hours of in-person test administration and parent counseling, followed by completion of a written report

**Feeding/Swallowing Evaluation: \$300** Includes up to 1.5 hours of in-person assessment and parent counseling, followed by completion of a written report

## Treatment Services

**Forty-five (45) Minute Treatment Session: \$75**

**Sixty (60) Minute Treatment Session: \$100**

## Additional Information Regarding Payment and Insurance

All payments are due at the time of service (in full) just prior to the start of the session. Credit card payments are conveniently handled through our online client portal (processed by the company Stripe).

All invoices (for HSA reimbursement) are automatically provided to you in the client portal following each session. Superbills are available upon request for submission directly to insurance.

It is important that you contact your insurance company prior to initiating the evaluation and/or treatment to understand your benefits if you plan on seeking reimbursement. Play by the Bay Therapy will be considered an out of network provider by your insurance company (and your reimbursement may be subject to different deductibles and rates on your plan than in-network providers).
